What is a Child Advocacy Center?

Child Advocacy Centers (CAC) are community-based, child-focused organizations that work alongside a multidisciplinary team to coordinate communities' responses to incidents of child abuse with the goal of promoting healing and justice for victims and their families. By coordinating the response of agencies like law enforcement, child protective services, prosecutors' offices, advocates, mental health, and medical professionals, CACs help ensure that when a child discloses abuse, they are not further victimized by the systems designed to protect them. From the initial allegation of abuse, the multidisciplinary team allows the child an opportunity to talk with a single interviewer in a safe, neutral setting, thus protecting the victim from being unnecessarily interviewed by multiple people from each specific field. The team continues to work together to guide the investigation, treatment, management, and possible prosecution of the case to ensure the greatest level of protection and care for the child victim and family.





Our Services

Red River Children's Advocacy Center provides services to children and their families at no cost to the child and family. These services are the stepping stones that enable our staff and partners to work as a team and support children and help them heal.



FORENSIC INTERVIEWS

Specially trained Forensic Interviewers work with the MDT to ensure children are not interviewed unnecessarily and allow them to share their experience in a safe, legally sound, and neutral setting.



MEDICAL EXAMS

Specialized medical evaluations are offered to ensure the health and safety of each victim, identify any evidence of abuse, and make referrals to additional care as needed.



ADVOCACY SESSIONS

Advocacy focuses on the needs of children and non-offending caregiver(s), and providing them with needed support and information along with a compassionate, listening ear.



MENTAL HEALTH CARE

Specialized trauma-specific and evidence-based mental health screening, assessment, and treatment are offered to children and families to help them cope with the trauma and work toward healing.



MDT COLLABORATION

Professionals from the CAC and MDT work together and share their expertise to reach the best outcomes for children.



PREVENTION

Education and training is provided with the tools needed to create a safe environment for children, fostering a culture of awareness and prevention.

THERAPY ROOMS (6 AVAILABLE)

Each of our mental health clinicians has a quiet and peaceful office that allows them to meet with clients in a calming atmosphere. We provide evidence-based trauma treatment for children and families exposed to various trauma such as sexual abuse, physical abuse, domestic violence, community violence, human trafficking, and neglect.

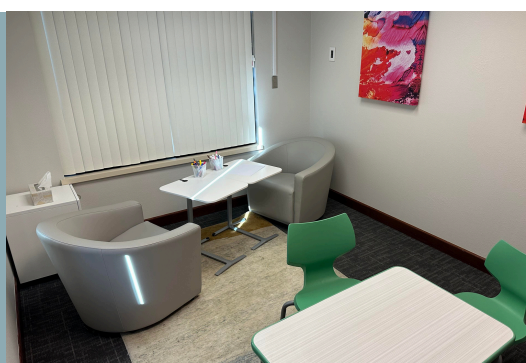

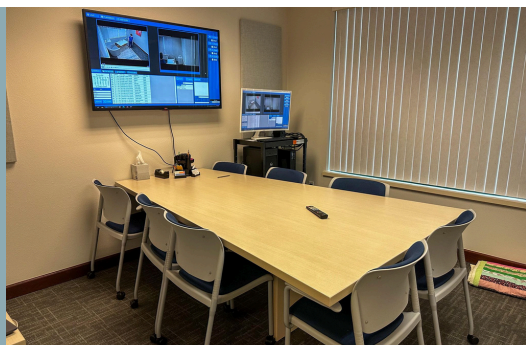

FAMILY ROOMS (1 AVAILABLE)

A family room is designed to support children and their caregiver(s) during their visit. The family room is a safe space to discuss their concerns and receive referrals to additional services. Overall, the family room serves as a supportive environment where children and caregivers can feel empowered and supported as they navigate through services.

The Team Room is where our partners meet during an interview, allowing them to observe the interview while it is being conducted. The team rooms allow the partners involved with the case a quiet and confidential space for partners to talk about the case, discuss the next steps, and meet with caregivers about the process.
