# Who We Are

---



## Red River Children's Advocacy Center

The Red River Children's Advocacy Center provides a compassionate and effective way to bring services to children victimized by abuse. Our public-private collaboration significantly reduces the trauma associated with reporting child abuse. We help coordinate care and investigation from first report to conviction and beyond, while keeping the child at the center of everything the team does.

## Our Mission

*To facilitate healing and justice for victims of sexual and physical abuse, neglect and exploitation, and to engage the community to protect and support children.*



# What We Do

CAC stands for Children’s Advocacy Center. CACs are community-based, child-focused organizations that work as part of a multidisciplinary team (MDT) to coordinate communities’ responses to incidents of child abuse with the goal of promoting healing and justice for victims and their families.

By coordinating the response of agencies like law enforcement, child protective services, prosecutors’ offices, advocates, mental health, and medical professionals, CACs help ensure that when a child discloses abuse, they are not further victimized by the systems designed to protect them. From the initial allegation of abuse, the multidisciplinary team allows the child an opportunity to talk with a single forensic interviewer in a safe, neutral setting, thus protecting the victim from being unnecessarily interviewed by multiple people from each specific field. The team continues to work together to guide the investigation, treatment, management, and possible prosecution of the case to ensure the greatest level of protection and care for the child victim and family.

# Our Services

---

Connecting to RRCAC's services starts with a referral from Law Enforcement or Social Services following reported allegations of any type of child abuse, maltreatment, or exploitation. Our professionals set in motion a process that will begin the **healing for children who have been abused**, as well as their family members.

Red River Children's Advocacy Center **provides services at no cost** to children and families. These services are the stepping stones that enable our staff and partners to work as a team to support children and help them heal.



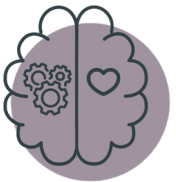
## Forensic Interviews

Specially trained Forensic Interviewers work with the MDT to ensure children are not interviewed unnecessarily and allow them to share their experience in a safe, legally sound, and neutral setting.



## Advocacy Sessions

Advocacy focuses on the needs of children and non-offending caregiver(s), providing them with needed support and information along with a compassionate, listening ear.



## Mental Health Care

Specialized trauma-specific and evidence-based mental health screening, assessment, and treatment are offered to children and families to help them cope with the trauma and work toward healing.



## Medical Exams

Specialized medical evaluations are offered to ensure the health and safety of each victim, identify any evidence of abuse, and make referrals to additional care as needed.



## MDT Collaboration

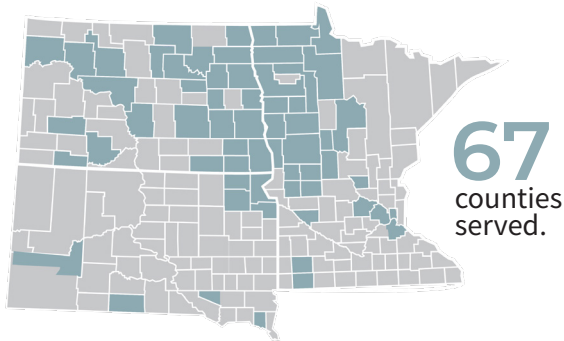
Professionals from the CAC and multi-disciplinary team work together and share their expertise to reach the best outcomes for children.

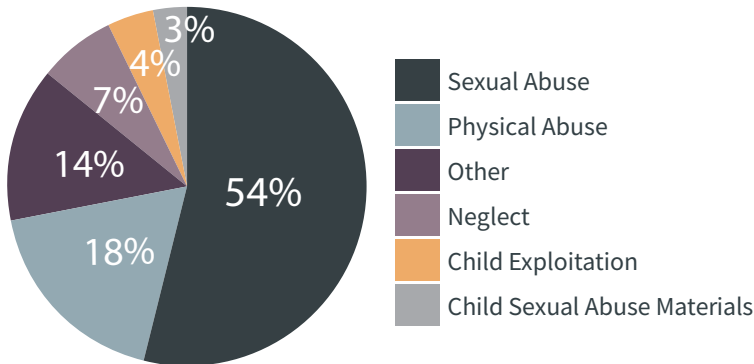
# Who We Serve



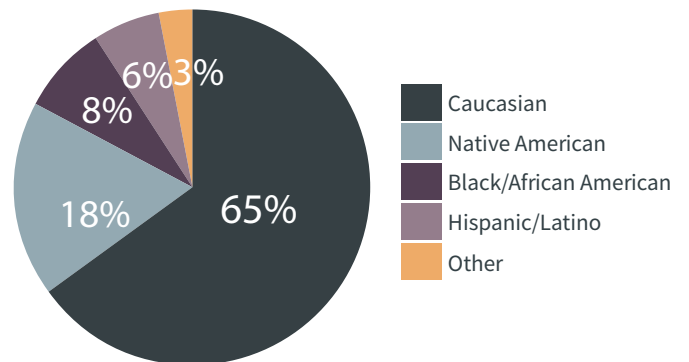

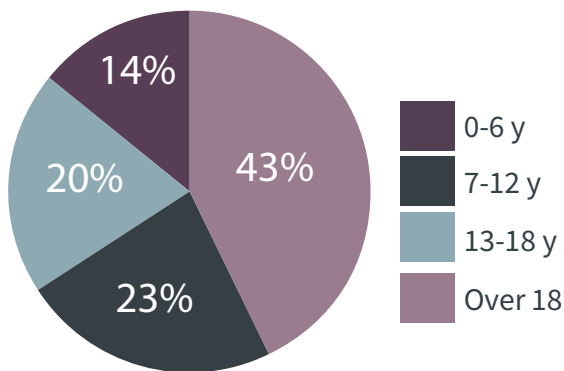
## Types of Abuse



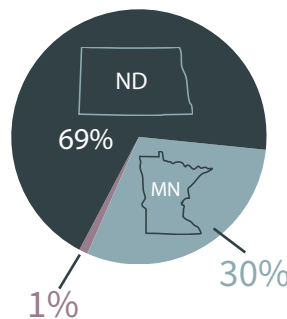

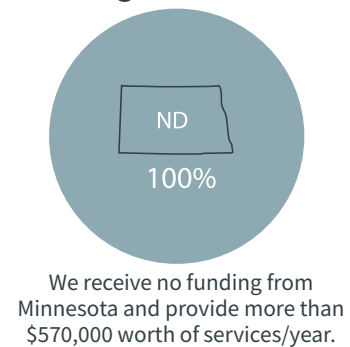
## Age

Our forensic interviewers attended a training that enhanced their skills in interviewing youth with a developmental disability, language delay, or autism.



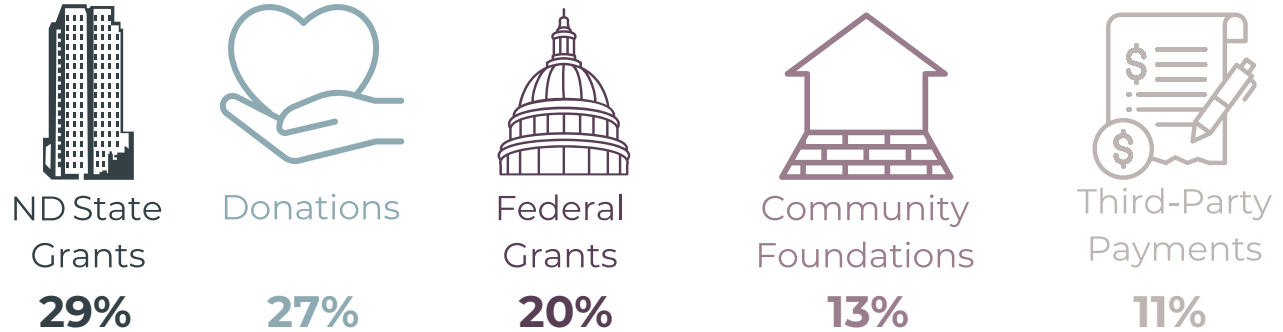
Our very own Chislaine Weisz was recognized as Child Advocate of the Year by the Grand Forks community for her work as a family advocate.

## Transforming Lives



A child completing therapy recently shared they “haven’t felt this good in a really long time,” reflecting the impact of consistent, trauma-informed care.



One teen who began treatment facing instability and limited family connection has shown significant reduction in trauma symptoms. Through coordinated support, the family now has stable housing, improved communication, reliable transportation to school, and access to community resources that support long-term stability.



Participants in our SPARCS trauma group reported strong connections and meaningful growth throughout the program. At graduation, several teens shared they would miss the group and the support they experienced there.

## Expanding Access to Care

### Connecting Students

Our telehealth SPARCS group currently connects 7 students from 7 different schools across North Dakota and Minnesota, expanding access to specialized trauma treatment across geographic boundaries.

### Supporting Families

Through collaboration with caregivers and partners, our team has successfully supported families in ways that help prevent placement disruptions and strengthen long-term stability for youth.

We continue to build partnerships with school districts, bringing services directly to students and reducing barriers to care for families in our region.

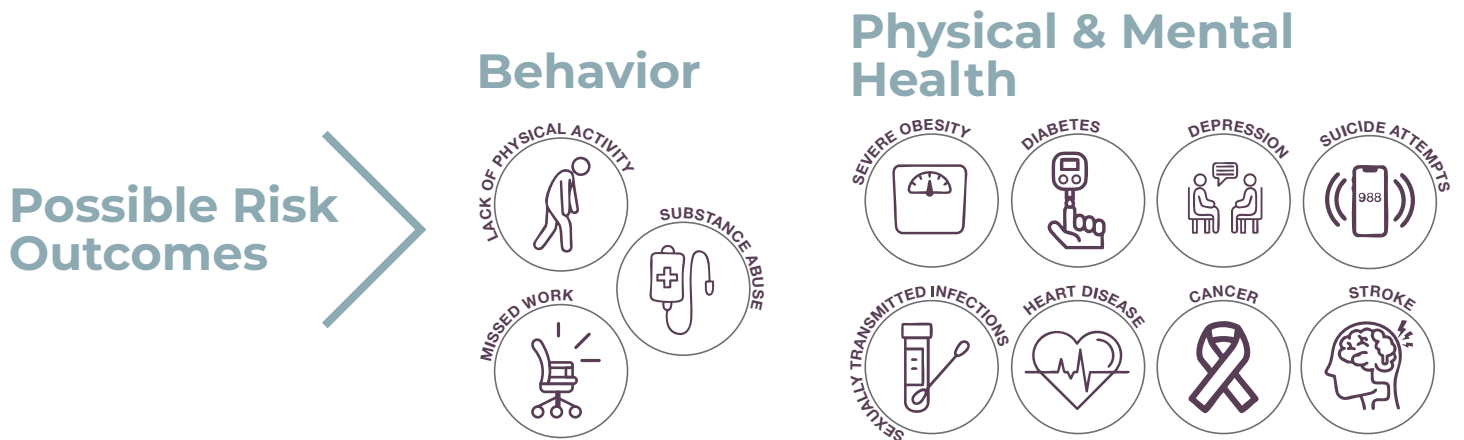

# Why It Matters

## The impact of childhood trauma can last a lifetime.

Child abuse and other forms of trauma can have lifelong effects on children, families, and communities.

Many studies have shown the strong relationship between Adverse Childhood Experiences (ACEs), which include childhood trauma like abuse, and serious outcomes such as post-traumatic stress disorder (PTSD), depression, substance use, health problems, and even poverty and early death.



## Trauma is both common and costly to society.

How many children are we talking about? Nearly half of all U.S. children experience at least one type of childhood trauma. That exacts a toll on children, their caregivers, their community, and our country as a whole. For in addition to the physical, emotional, and social costs of child abuse, such trauma also carries economic costs.

### Abuse and other forms of trauma are common.

Nearly half of all U.S. children—

some **34 million**—have experienced at least one type of childhood trauma, while

**16 million** have experienced two or more types of trauma.<sup>2</sup>

### Abuse carries a heavy cost.

The lifetime cost for each victim is

**\$210,012**

Each year, total lifetime costs of new cases of child abuse reach approximately

**\$124 billion<sup>1</sup>**
